1. eFiling is optional and is an alternative to filing printed documents by hand.
2. Filing fees and costs are processed electronically through PeachCourt at the time of filing.



# eFiling has arrived

A few things you need to know:

## Who can eFile?

Any member of the Georgia State Bar can register at no cost.

## What can I eFile?

You can initiate and file into General Civil and Domestic Relations cases.

## When can I eFile?

PeachCourt is open 24/7. No more rushing to beat a 5 PM deadline.

## Where can I eFile?

You can file in State and Superior Courts across Georgia. Visit PeachCourt.com to see the list.
