The announcements to be made are READY, NON-JURY, REQUEST CONTINUANCE or NOT READY. If you announce "request continuance" or "not ready", you will need to submit a detailed explanation for that announcement. Continuances will be granted for any case less than a year old if all parties agree to the continuance. Any request for a continuance on cases older than a year will have to be approved by the Judge. If you announce Non-Jury, all attorneys will need to sign a Waiver of Jury Trial. That form may be found on www.putnamcourtclerk.org under the forms tab.

Pursuant to said Uniform Rule 20, if a party fails to appear at the calendar sounding or otherwise to advise the Court, the Court may dismiss without prejudice the plaintiff's action or defendant's answer, counterclaim or cross claim. **A conflict letter or leave of absence will not relieve you from making a formal announcement to the Court.**

All orders for cases settled prior to trial, previously disposed of by trial or settlement are to be filed no later than 5:00 p.m. on Wednesday, November 21, 2018.

Under the Uniform Superior Court Rules, if a party fails to answer when the Court calls their case during the Court term, the Court may dismiss the case, any claims, or a party's pleadings. It is also the party's duty to be sure that the Clerk of Court has their accurate and current mailing addresses and phone numbers.

ALL CASES ANNOUNCING NON-JURY WILL BE HEARD AT 9:00 a.m. ON THURSDAY, JANUARY 3, 2019.

BANKRUPTCY PETITION: If a Bankruptcy Petition has been filed in a case, the parties must provide written proof, filed at least a week prior to this calendar, that the Bankruptcy case is either still pending or that the debt/liability in this case has been discharged.

UNIFORM RULES FOR THE SUPERIOR COURTS

Rule 8.3. Trial calendar

...The calendar clerk may distribute the calendar by sending an electronic copy via e-mail to the attorneys of record addressed to their e-mail addresses as registered with the State Bar of Georgia pursuant to USCR 4.2. Pro se parties must be notified by regular mail.

Rule 20. Peremptory calendar.

Periodically the assigned judge may cause to be delivered to the clerk of the court and published a list of pending civil actions in which the discovery period has expiredupon reasonable notice requiring the parties (including the state) or their attorneys to announce whether the actions or cases appearing thereon are ready for trial and when trial should be scheduled. **Failure to appear at the calendar sounding or otherwise to advise the judge or appropriate calendar clerk may result in the following disposition:**

- (A) **In civil actions, the dismissal without prejudice of plaintiff's action or defendant's answer, counterclaim, or cross-claim...**

The calendar for the trial week will be a **Rule 14 calendar.**

Rule 14. Dismissal.

On its own motion or upon motion of the opposite party, the court may dismiss without prejudice any civil action, or where appropriate, any pleading filed on behalf of any party upon the failure to properly respond to the call of the action for trial or other proceeding. In civil actions or criminal cases the court may adjudge any attorney in contempt for failure to appear without legal excuse upon the call of any proceeding.

Rule 4.10 To notify of settlements and dismissals.

Immediately upon the settlement or dismissal of any civil action the involved attorneys shall notify the assigned judge and, where appropriate, the calendar clerk of such event.

Rule 5.1 Prompt completion

In order for a party to utilize the court's compulsory process to compel discovery, any desired discovery procedures must first be commenced promptly, pursued diligently and completed without unnecessary delay and within six months after the filing of the answer. At any time, the court, in its discretion, may extend, reopen or shorten the time to utilize the court's compulsory process to compel discovery.
